

## Report on Local Law 249-2017 FY2019 4th Quarter

August 2019



## Introduction

The New York City Council passed Local Law 249, requiring the Department of Finance (DOF) to notify property owners when real estate instruments are recorded on their properties, on November 16, 2017. The law took effect July 1, 2018.

Local Law 249 mandates that DOF provide a quarterly report to the council and publish the report on the department's website. The report must include:

- 1) Total number of individuals registered to receive notification, disaggregated by the type of interested party
- 2) Total number of individuals registered to receive notification for multiple properties
- 3) Total number of properties for which an individual is registered to receive notifications
- 4) Total number of individuals who opted out of receiving notifications
- 5) Total number of individuals who contacted the department regarding an incorrect or suspected fraudulent document recording, grouped by the source of information that led to contacting the agency
- 6) Total number of referrals made by the New York City Register or Richmond County Clerk related to suspected fraudulent document recording, the outcome of the referrals, and information about investigations conducted by the Sheriff's Office.

## **Findings**

Below is the Department of Finance's fourth-quarter 2019 report on Local Law 249. It contains data through June 30, 2019.

The City Register referred 34 cases to the Sheriff's Office due to investigate the suspected submission of fraudulent documents.
